

## Simple and Straightforward

The decision to file 'educated,' like any newly discovered assertion of personal power, requires a bit of courage. But not so much these days, since so many patriots have upheld the law before you.

The process is quite simple. You are essentially using your Form 1040 and modifying applicable reporting forms—the 1099 and the W2 via a Form 4852—to accurately reflect your income. If payment of tax-relevant income to you has been erroneously alleged on a form such as a W2, you rebut the allegation by accurately reporting on your tax forms what tax-related income you actually did have, if any, and claim for refund any amounts improperly withheld from you.

Report true income. For example, Social Security benefits are such (but if < \$25K for an individual, not taxed). The site is more than helpful on the minor wrinkles.

## The Steps

3. Duplicate the process.

All it takes to bring down the Emperor tomorrow is **one or two** of you attesting to his obvious lack of clothing today.

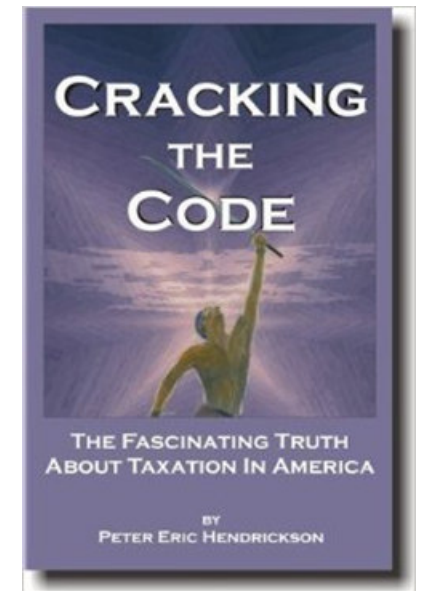
While you're at it, bang the drums for Doreen's full restitution and grand jury indictments of her tormentors! **Man up!**
